

#### R&GVRRM MEMBERSHIP MEETING JANUARY 17, 2013

The January Museum Membership Meeting was called to order at the 40&8 Club, 933 University Avenue, Rochester, at 7:30 p.m. Museum trustee Otto Vondrak presiding.

Membership Report: Sam Rosenberg reported that there were two new members, Thomas Seils of Rochester, and Ralph Dressler of Geneva. The LA&L trip got us around 10/12 new members; we are at an 80% renewal rate. A MOTION was made by Jeremy Tuke to accept the candidates as new members. The motion passed unanimously.

Preservation Report: Dave Scheidrich reported that the storm sewer plumbing project is complete. The sanitary sewer is on its way to completion. In the spring of this year an inspection pit will be constructed on the east track at the north end of the Restoration Building. Rules Classes are in the planning stages. Joe Nugent reported that our Lehigh Valley caboose projet is moving along with the lower wall wood removed and there is some sheet metal work to be done. Otto Vondrak reported that the old center display from the depot waiting room has been rebuilt and relocated into the Lackawanna baggage car.

#### PRIORITY PROJECTS FOR 2013

In order to better focus our resources and to help our volunteers identify where they can make the most impact, your Board of Trustees has identified several projects as priorities to work on through 2013. Some items we would like to complete this year, others we realize may take a bit longer. Please take a moment to look over this list and think about where you might be able to help out: 1) Design and Construction of Inspection Pit Inside the Restoration Building: Completion of this project will help us maintain our fleet of operating equipment for years to come, and allow us to perform certain maintenance tasks that

are nearly impossible at present. 2) Finish **Landscaping the Area North of Industry Depot:** Since the removal of display Track 1 and 2 many years ago, the area north of the depot has been awaiting the completion of landscaping in this area. Work will consist of burying an electrical conduit, finish grading, and planting of grass seed (see January 2013 issue of THE SEMAPHORE for details). 3) Completion of our Sanitary **Sewer:** Once the old sewer is transferred from state to county control, we should be able to quickly complete the design and implementation of our sanitary sewer plan. This will allow us to restore our bathroom facilities inside Industry Depot. 4) Completing the Fill South of the **Restoration Building:** Once we complete the fill and grading of the land south of the Restoration Building, we will be able to extend our tracks and create a long-term storage area for certain pieces of equipment. 5) Completion of Empire State Express Coach #1: The scope of this project includes the completion of interior painting, the installation of new heating and electrical systems, the reinstallation of the coach seats, and many other small tasks to return this car to active duty.

6) Repair and Repaint the Roof of the Lackawanna Baggage Car: The roof of the car that holds many of our displays is rapidly deteriorating and will require repair and refinishing this year so it may continue to serve. 7) Completion of Repairs to RG&E #8: We hope to complete the major mechanical work on this locomotive this year, which will give us greater flexibility in our diesel operations. 8) Repair a Third Track Car and Trailer: So that we can meet periods of peak demand when the diesels are not operating, we must repair a third track car and trailer set from our existing fleet of equipment.

While this may seem like a long list, many of these projects have already started. In the coming months, we will be calling upon our volunteers to help us meet our goals so that our museum can continue to grow and fulfill its mission. # US&S Countdown Timer Donated by LIRR While this looks like a candy jar, there is indeed a different kind of treat sealed inside



While this looks like a candy jar, there is indeed a different kind of treat sealed inside this glass. Donated to our museum by the MTA Long Island Rail Road, this is a Union Switch & Signal TC-10 clockwork release. Timers like this were used in approach interlockings. Once the tower operator had given a train the proceed signal, he could not change the route until the signal had been returned to red for a set amount of time. The length of time was figured to be enough so that a train having already passed the approach signal to an interlocking would have time to see the red signal and stop. Even if the train passed the red signal, there was no danger since the route was unchanged. With out an approach locking it would possible for an operator to make a mistake; such as giving a proceed signal and then taking it way to change the route (perhaps into another train). This timer was salvaged from a tower on the LIRR that was recently closed after more than a century of service on the busy urban commuter line. The railroad has been modernizing and consolidating its busiest junctions by replacing old mechanical relays with new interlockings that rely on computers and software to perform the same functions. This piece will eventually go on display at our museum with our interlocking machines and other vintage railroad signal equipment. — Mike Dow

#### **Article IV- Elections - Current**

- 1. All officers and those trustees whose term expires shall be elected at the regular May meeting by majority vote of all eligible members voting in person or by mailed ballot. Mailed ballots must be received at the RGVRRM mailing address before the May meeting.
- 2. Prior to the regular April meeting, a Nominating Committee shall meet and select a slate of officers and trustees. This committee shall consist of four RGVRRM members. Two of these members will be carry over trustees, one of which will serve as chairman, as nominated by the President and confirmed by the remainder of the board by majority vote. The two confirmed trustees shall select two members who are not currently serving on the board or seeking nomination.
- 3. At the regular April meeting, the Nominating Committee shall announce their slate of candidates, then the President shall call for additional nominations from the floor. It will be the job of the Nominating Committee chairman to contact those nominated from the floor that were not present, if any, and ask those individuals if they will accept the nomination. If they accept, those names will be added to the ballot of candidates selected by the Nominating Committee.
- 4. The ballot shall be published in the May issue of the RGVRRM news letter as a ballot that can be mailed in. This issue shall be mailed not less than ten days prior to the meeting date.
  - 4.1 At the regular May meeting the election shall then be conducted by majority vote from the ballot of candidates published. If a majority vote is not obtained, a run off election will be held immediately, from the candidates receiving the two highest percentages of votes for that office.
- 5. In the event of a vacancy in the ranks of officers, National Director, or trustees, the vacancy shall be filled by the following: The trustees, by majority vote, shall appoint a RGVRRM member to fill the office until the next regular election. The remaining term of the office shall then be filled by the nomination and election procedure as prescribed above.
- 6. Electees will take office at the first Trustee's meeting following the completion of the election.

#### **Article IV- Elections - PROPOSED CHANGE**

- 1. All officers and those trustees whose term expires shall be elected at the regular **November** meeting by majority vote of all eligible members voting in person or by mailed ballot. Mailed ballots must be received at the RGVRRM mailing address before the November meeting.
- 2. Prior to the regular **October** meeting, a Nominating Committee

- shall meet and select a slate of officers and trustees. This committee shall consist of four RGVRRM members. Two of these members will be carry over trustees, one of which will serve as chairman, as nominated by the President and confirmed by the remainder of the board by majority vote. The two confirmed trustees shall select two members who are not currently serving on the board or seeking nomination.
- 3. At the regular **October** meeting, the Nominating Committee shall announce their slate of candidates, then the President shall call for additional nominations from the floor. It will be the job of the Nominating Committee chairman to contact those nominated from the floor that were not present, if any, and ask those individuals if they will accept the nomination. If they accept, those names will be added to the ballot of candidates selected by the Nominating Committee.
- 4. The ballot shall be published in the **November** issue of the RGVRRM newsletter as a ballot that can be mailed in. This issue shall be mailed not less than ten days prior to the meeting date.
- 4.1 At the regular **November** meeting the election shall then be conducted by majority vote from the ballot of candidates published. If a majority vote is not obtained, a run off election will be held immediately, from the candidates receiving the two highest percentages of votes for that office.
- 5. In the event of a vacancy in the ranks of officers, [delete: *National Director*,] or trustees, the vacancy shall be filled by the following: The trustees, by majority vote, shall appoint a RGVR-RM member to fill the office until the next regular election. The remaining term of the office shall then be filled by the nomination and election procedure as prescribed above.
- 6. Electees will take office at the first Trustee's meeting in **January**.
- 7. After the passage of this change, those whose terms expire in may will be extended until the end of that year, and their elections will occur in November.

This proposed change is so that new board members will not take office after the operating season has begun. Also the mention of national director was removed from paragraph 5. November was chosen for the election because December meetings are very close to Christmas and normally not many attend. Paragraph 7 was added to allow a simple change over to the new system, without having to have a second election in the same year. Moving the election will also allow the May meeting to be held at the depot where there is more daylight than in September. This would also move member slide night to the November meeting.

### PROJECT UPDATE

Our Lehigh Valley caboose is getting some much needed attention on the interior, where paint is being stripped off of all wood and metal surfaces, and some repairs have already begun. Some wooden panels have been removed so that we have access to the exterior steelwork so repairs can begin there as well. Our goal is to have the exterior prepared for primer and paint by this summer. ### New Amtrak Cars Coming Soon To Be Built in Elmira

Amtrak says the first four of eight prototypes of its 130-car, single-level long-distance equipment order will be delivered late this year and, after testing, could enter service by mid-2014. The prototypes will include one each of the 25 sleepers, 25 diners, 25 baggage-dorms, and 55 full baggage cars, which will allow Amtrak to retire its remaining heritage equipment, some of which is more than 60 years old.

The stainless steel cars are based on the quarter-century old Budd Viewliner design and are being built from the ground up at by CAF USA, the North American subsidiary of Spain's Construcciones y Auxiliar de Ferrocarriles, S.A., at its facility in Elmira, New York. In order to make the Amtrak cars, particularly the



stainless steel shells, CAF USA has installed additional overhead cranes, CNC metal cutting and robotic welding equipment — one reason for the time lag between the company getting the contract and the actual start of


the production work. About 100 employees, welders, quality assurance and purchasing staffers, have also been hired. The order is expected to be completed by 2015.


